Chapter 4

Section 1 a: A person who, in a case other than those stated in Section 1, by using unlawful coercion or deceit, by exploiting someone's vulnerability or by any other such improper means, recruits, transports, transfers, harbours or receives a person with the aim of exploiting him or her for sexual purposes, the removal of organs, military service, forced labour or any other activity in a situation that involves distress for the person thus exploited, shall be convicted of *human trafficking* and sentenced to a minimum of two years and a maximum of ten years in prison.

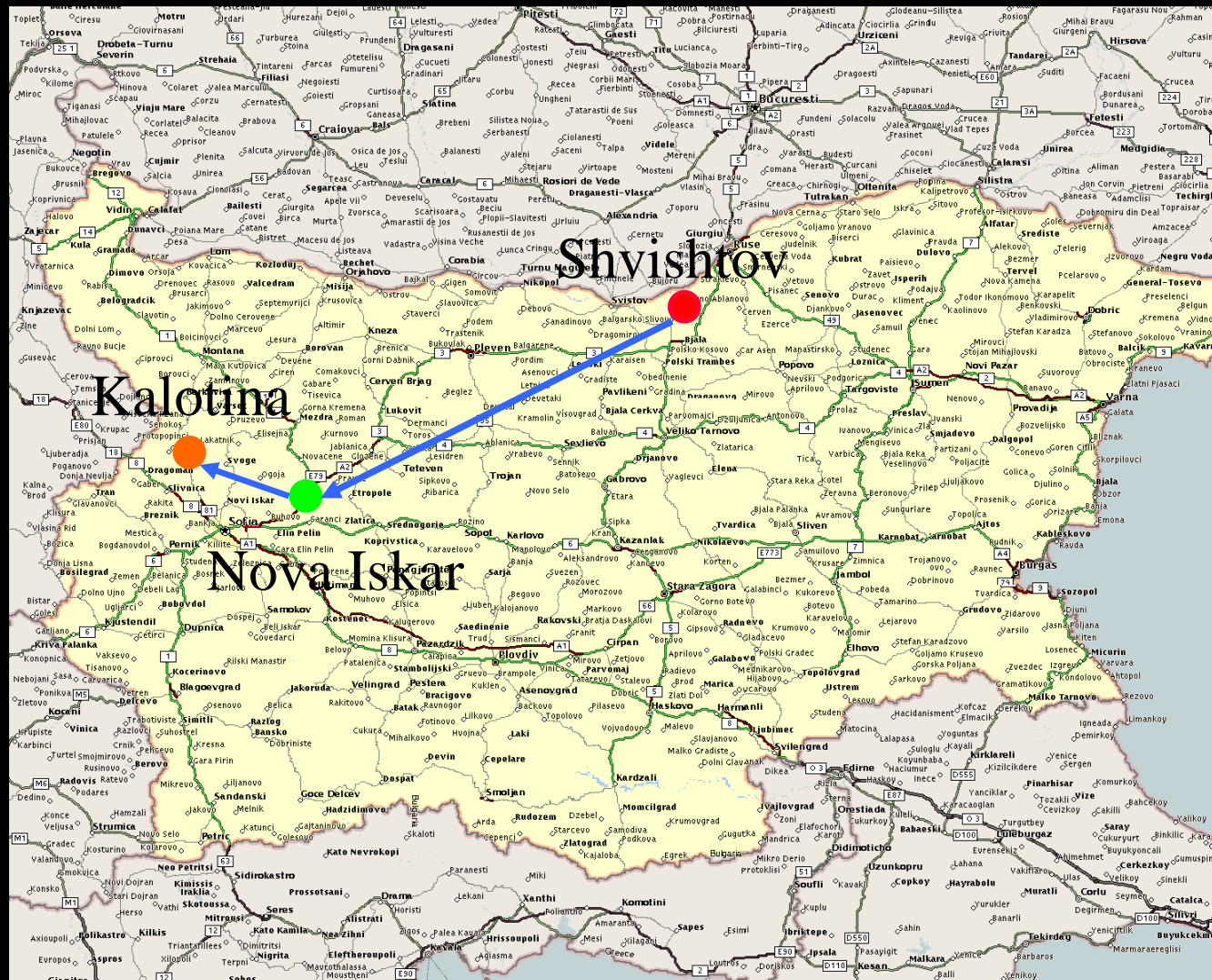
Anyone who commits a crime as referred to in paragraph 1 against a person who has not yet reached the age of eighteen, shall be convicted of human trafficking even if none of the improper means stated therein have been used.

If a crime, as referred to in paragraph 1 or 2, is of a less serious nature, this is punishable with up to four years imprisonment.

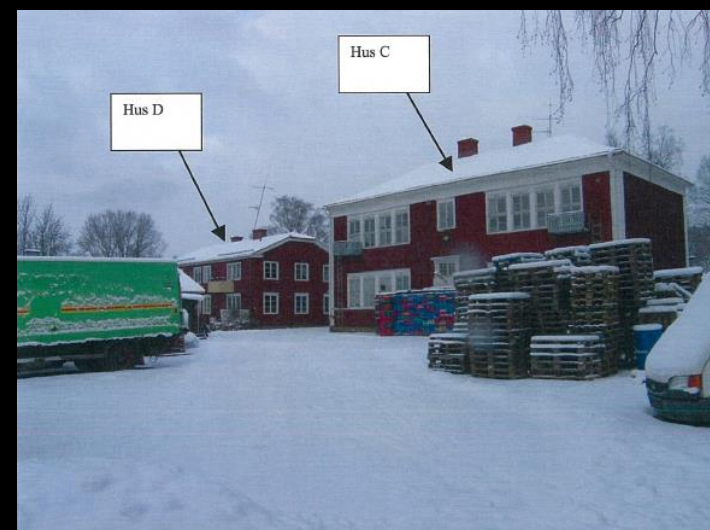
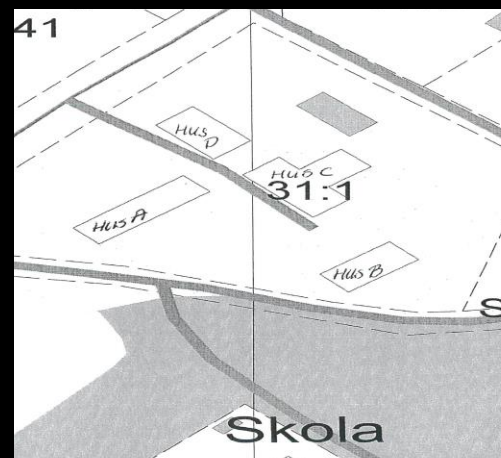

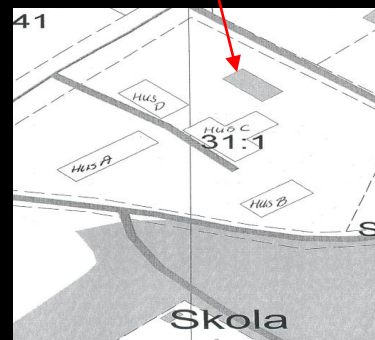

Chapter 4

Section 1 a: A person who, in a case other than those stated in Section 1, by using unlawful coercion or deceit, by exploiting someone's vulnerability or by any other such improper means, recruits, transports, transfers, harbours or receives a person with the aim of exploiting him or her for sexual purposes, the removal of organs, military service, forced labour or any other activity in a situation that involves distress for the person thus exploited, shall be convicted of *human trafficking* and sentenced to a minimum of two years and a maximum of ten years in prison.

Anyone who commits a crime as referred to in paragraph 1 against a person who has not yet reached the age of eighteen, shall be convicted of human trafficking even if none of the improper means stated therein have been used.

If a crime, as referred to in paragraph 1 or 2, is of a less serious nature, this is punishable with up to four years imprisonment.
