

- Establish Norden as one, inner market and a borderless region through removal of barriers and stimulating increased competition.




#### Innovation - defined



#### The innovation process From idea to market



## Initiating and investing

NICe invests in projects and networks:

- Removing barriers
  - Venture capital, Methods, Markets, Human Resources, etc.
- Enhancing innovation capabilities
  - Sharing knowledge and experience
  - Synergy
  - Critical mass
  - New sectors with great potential



#### Basic requirements

- The project must include partners from at least three (ideally, all five) Nordic countries.
- The project should be at least 50% self-financed, either in the form of working hours or direct funding
- The project period must not exceed 36 months



#### Project criteria


The project shall:

- Relate to Nordic and international best practice
- Create and develop markets

## ERA-Net project - SafeFoodEra



- Create a European platform for producing food products that do not harm the consumers.
- Building European excellence in food safety through coordinated research and improved business innovations
- EU funding: 32 MNOK (4 MEUR) within the 6th Framework Programme
- 20 participating countries
- Based on Nordic success criteria: Trust and mutual understanding

- 2003: NICe establishes Food Safety as a Focus Area and finances 4 Nordic projects




