

The objectives of the policy

Achieve equality in living conditions and full participation for people with disabilities in a diverse society and actively contribute to increased gender equality and to consider the rights of children



The direction of the policy

- The principle of universal design
- Identify shortcomings in accessibility
- Individual support and solutions for individual independence
- Prevent and counteract discrimination





Swedish Agency for Participation

Participation

- To be a part of on equal terms
- The right to participate is a human right
- Autonomi and selfdetermination



Accessibility

- The environment
- Transports
- Information and communication
- Goods, products, services and digital solutions





Universal design

The concept of universal design describes how products, the environment and services can be used by as many people as possible without any special adaptation. Diversity in the process is crucial to the outcome





Active involvement

 According to the CRPD, the states must actively involve organizations that represents persons with disabilities. So it works in Sweden.





The Swedish Agency for Participation

- Director General and 50 employees
- Agency under the Ministry of Social Affairs
- One of 342 agencies in Sweden

- They provide guidance and tips in the work of increasing participation.
- There is a tool for dialogue with people with disabilities and one for developing strategies.

Accessible elections

- The voting process does not yet provide for the full participation of all citizens
- Many balloting stations have been shown to have shortcomings concerning accessibility

 In Sweden, since January 2022 it is The Swedish Institute for Human Rights






Local implementation
