1994 Act on Support and Services for Certain Persons with Functional Impairments

- Possibilities of living like others
- Equal opportunities
- Equality
- Full participation in society

To get access:

- Apply yourself
- Individual assessment and decision
- All municipalities shall provide info about the law and rights

Responsibilities

- Central government – general planning, legislation, social insurance
- County councils/regional government – health care
- City councils/municipalities – social services for everyone




